The Coalition to Counter Online Antisemitism (CCOA) brings together a wide range of actors working to address antisemitism online with the aim of building new partnerships and strengthening existing efforts. CCOA works to connect research, education, and policy practice, and to amplify effective approaches across Europe. The initiative unites over 90 stakeholders in ten European countries, including Austria, Belgium, Denmark, France, Germany, Italy, Poland, Spain, Sweden and the United Kingdom.

Programme Overview

The Coalition to Counter Online Antisemitism is launching its third cohort of the CCOA European Multiplier Training Programme, a three-month European training programme designed for educators, practitioners, community leaders, civil society actors, policy and government professionals and researchers from a wide range of professional and community backgrounds. Rooted in CCOA's evidence-based approach and guided by the principle of moving from insight to impact, the programme supports participants in translating research, evidence and lived experience into effective educational and community-based responses to online antisemitism and digital hate.

Structured as a progressive learning journey, the programme guides participants through a series of interconnected stages: understanding the challenge, recognising harm, exploring prevention and response approaches, designing practical initiatives, and assessing how sustainable impact can be achieved. In doing so, it seeks to strengthen a growing European community of practice committed to addressing online antisemitism through education, prevention and democratic engagement. The sessions aim to create a balanced connection between the fields of practice, policy, and research, while providing participants with new insights to develop ideas and initiatives to address online antisemitism within their own contexts. Participants are also encouraged to reflect on the evolving ways antisemitism manifests online and its intersections with other forms of hate. Through interactive learning, peer exchange and collaborative problem-solving, participants will explore evidence-based approaches that can help create safer and more inclusive online and offline environments.

The programme welcomes participants with a broad range of experiences and backgrounds. It recognises that meaningful responses to online antisemitism are strengthened by bringing

together lived experience, local and community knowledge, professional practice, education, research, and policy perspectives.

Throughout the programme, participants will

- Build confidence in recognising and responding to online antisemitism and its intersections with other forms of hate,
- Explore strategies for strengthening digital resilience, online safety and democratic participation within communities and organisations,
- Explore and develop concepts for initiatives aimed at countering online antisemitism,
- Gain knowledge of Monitoring & Evaluation approaches to apply them to prevention programmes and interventions,
- Connect with peers from across Europe and become part of a growing network of multipliers committed to fostering more inclusive, resilient and democratic digital spaces.

A distinctive feature of the programme is its emphasis on understanding not only what works, but also why it works. Attention is given to discussing best practices for translating evidence into effective prevention practice, including approaches to impact evaluation. Participants will strengthen their ability to critically assess existing approaches, identify gaps in current practice and deepen their understanding of the factors that contribute to meaningful and lasting impact. Throughout and beyond the training, the cohort will become part of a European community of practice, fostering peer exchange, mutual learning and support across borders and sectors.
